# Cook County Slate Has Experience

After a relatively quiet primary season, Cook County Democrats are preparing to re-elect a slate of incumbents to several county offices in November.

Leading the ticket is Cook County State's Attorney Richard A. Devine, who has held that post since 1996. In his reelection campaign, Devine is emphasizing a nationally acclaimed Domestic Violence Unit and a Victim/Witness program which the United States Department of Justice is using as a model for other locations to follow. Devine is also proud of his death penalty reforms which include updated procedures in handling suspects in capital cases.

Going for her second term as Clerk of the Circuit Court of Cook County, Dorothy Brown is stressing her accomplishments in updating the back office of the court system, including new information technology systems, improved customer service, employee development and training and financial accountability.

Also seeking a second term is Cook County Recorder of Deeds Eugene Moore, a former member of the Illinois House of Representatives who served with Tenth Congressional District Democrats Chair Lauren Beth Gash. His office is the second largest of its kind in the nation. Moore implemented a state-of-the-art cashing system and increased production with a reduced staff.

The Metropolitan Water Reclamation District has three Democratic commissioners up for reelection. This all woman team includes Gloria Alitto Majewski, Patricia Young and Barbara J. McGowan.

The District manages the waterways in Cook County and the storm water that empties into these bodies of water. Its major project has been the ongoing Deep Tunnel system that is managing flood control and storm water in the county.

## Rep. Washington Sees Key Issue

Our current jobless recovery brings to mind James Carville's prophetic words spoken when the Bush 41 occupied the White House, "It's the economy, stupid."


State Rep. Eddie Washington (D-Waukegan), whose district covers North Chicago and Waukegan, has devoted much of his first term to fostering economic development in his 60th Legislative District. With respect to the upcoming Tenth Congressional District contest between Democratic challenger Lee Goodman and Republican incumbent Rep. Mark Kirk (R-Ill.), Washington says, "The key issue is the economy and with it, economic development."

"In my area, the school impact formula comes to mind," said Washington. "Naturally, the school systems in North Chicago are always under stress because of the amount of military personnel families that attend the public schools. And yet the compensation does not take place in a timely fashion as did the \$87 billion going outside the country for the Iraq War.

"And we still have a war on poverty and a war on ignorance that's being ignored. I'd like to see the school district compensated on a timely basis where the state of Illinois and School District 187 are not put under a strain and always made to play catch up. They need those dollars to continue the kind of quality education they're trying to achieve."

The first-term legislator also decries the building of more retail businesses inside the Great Lakes Naval Base instead of outside the perimeter as a drag on economic development. That way the local tax base can benefit and job opportunities can be provided. This "friendly fire" by the Federal government is depressing his district and Washington wants to fight it. "Incentives must be created to have these same retailers locate around the perimeter of the base in North Chicago, where the local residents, too, can enjoy some of the tax benefits."

Washington, who has been a strong advocate for his constituents during his first term, said, "That is a major problem the way I see it."



## 10th Dems March

# Mark Kirk: Thoughtful Warmonger

During the run-up to the Republican war in Iraq, Rep. Mark Kirk (R-Ill.), whose background includes a stint in naval "intelligence," came out early in identifying Iraq as a clear and present danger to America.

On October 8, 2002, Kirk told Congress that "the Iraqi regime represents a growing present danger to the United States. . ." Kirk then voted for a joint Congressional resolution which authorized President Bush to use the U.S. military force against Iraq.

Since President Bush initiated hostilities against Iraq in March, 2003, Kirk has been an unflinching supporter of "Operation Iraqi Freedom." Kirk voted for the \$87 billion dollar special appropriation to make the first installment payment of the costly war in Iraq.

Apparently in league with the White House misinformation campaign to justify the war, Kirk repeatedly informed his constituents that the former Iraqi regime possessed weapons of mass destruction that justified the war. For example, for months Kirk's official congressional website recommended a highly flawed assessment of the British government on "Iraq's Weapons of Mass Destruction" as a "thorough summary of the current situation within Iraq."

In a letter to a constituent, Kirk actually claimed that U.S. forces had found weapons of mass destruction in Iraq. Citing Colin Powell's address to the U.N., warning of dangerous mobile chemical weapons laboratories, Kirk claimed that soldiers of the Third Infantry had actually discovered such mobile weapons factories.

In fact, as U.S. weapons inspector, David Kay, has publicly acknowledged, the consensus within the United States intelligence community is that the mobile trailers found in Iraq were actually designed to produce hydrogen for weather balloons, or perhaps to produce rocket fuel.

Kirk owned up to only "one piece" of intelligence as wrong: The President's claims about a purported Iraqi attempt to purchase uranium from Niger, claims that the government knew to be false because of reports it had received from Joseph Wilson in early 2002.

Kirk likes to portray himself as a thoughtful, independent member of Congress. In fact, on matters of war and peace, he follows the lead of his President and party 100% of the time.

To effect real change in our country's national security policies, it is not enough to merely get rid of the administration that makes those policies. It is time to get rid of members of Congress like Mark Kirk who support those policies.
