Dan Seals Is Just About There

It has been over a year since I first met Dan Seals. He was only considering a run for Congress at the time. The latest poll says he is just 2 percentage points behind Mark Kirk, with a 3-point margin of error in the poll. He has come an amazingly long way in a short period of time.

When he made the decision to run for Congress, he knew the odds were against him. Almost everyone told him that Republican Congressman Mark Kirk was unbeatable. Kirk had won with 64 percent of the vote in 2004 and 69 percent in 2002. Kirk had over a million dollars in the bank. Kirk was fairly well known in the area. As an incumbent Congressman, Kirk could hold news conferences that would actually be attended by members of the local media, and by the next day thousands of 10th District residents would read or hear Mark Kirk's name. Kirk could take credit for Congressional funding for local projects that he may, or may not, have done much of anything to bring about...and be front and center when the cameras took photos of the check being presented.

By contrast, one year ago who knew anything about Dan Seals? When you think about that, you have to be impressed by what Dan Seals has accomplished, and how much it says about him as a candidate, a leader and very possibly, our next congressman.

Sure, you have to give some credit to the Republican President, George Bush. His administration has fumbled its way through Iraq, Katrina, and...well, you know the list. You have to give some credit to the Republican Congress, which gave us "leaders" such as Tom DeLay, Duke Cunningham, Bob Ney and Mark Foley, while doing

almost nothing but rubber-stamp the President's policies on the war in Iraq, the economy, and...well, you know the list.

And, you have to give major credit to Republican Mark Kirk. He has spent the past few years proving that his number one priority in Congress is to promote his political career. All his talk about being a

"thoughtful, independent leader" turned out to be nothing more than just another Republican phrase designed to hide the truth. In order to climb the Congressional ladder, Kirk had to please his masters, and to do it he gave up any independence he may have once had. When they needed votes to interfere in the Terry Schaivo case, Kirk fell into line. When they needed votes to give oil companies a break, even at the expense of environmental causes that Kirk claimed to support, Kirk fell into line. He even voted to weaken House ethics laws when the Republicans were trying to protect Tom DeLay. Did Mark Kirk really believe that 10th District residents wanted House

Kirk Proves to be Pro-/Anti- –Seals Is the Only Choice

Mark Kirk says he is pro-choice and has the Planned Parenthood endorsement to prove it. Just don't examine his record.

During the past six months or so, Planned Parenthood supporters have received action alerts urging us to write our Congressman to support these bills:

- Responsible Education About Life Act
- Equity in Prescription Insurance Contraceptive Coverage Act
- Prevention First Act
- Stop Deceptive Advertising for Women's Services Act
- Freedom of Choice Act
- Guarantee of Medical Accuracy in Sex Education Act
- The PATHWAY Act (AIDS prevention).

Kirk won't sponsor those bills. How he can still have the Planned Parenthood endorsement is hard to fathom. I applaud the NARAL Pro-Choice America for seeing the light and dropping its endorsement of Mr. Kirk.

These pages have previously documented Mark Kirk's uniformly failed pro-choice votes, his behind-the-scenes anti-choice procedural votes, his vote to protect perpetrators of clinic violence from paying damages by declaring bankruptcy and his donations to right-wing candidates with zero percent scores from Planned Parenthood.

Meanwhile, clinic violence continues; our tax dollars are spent on inaccurate, unhealthy sex education; the 30th anniversary of the Hyde Amendment denying poor women abortions comes and goes; abortion hotlines struggle to keep funded; Chicago hosts the "Contraception is Not the Answer" conference; and Congress votes for nearly the 150th time in the last decade to restrict abortion and contraception. Reality check: 2 percent of women of reproductive age in the U.S. have abortions annually, an estimated one-third or more U.S. women have abortions at some point and 98 percent of U.S. women use contraception during their lifetimes.

After what's happened during his terms in Congress, Mr. Kirk does not deserve to call himself pro-choice.

What do we need? We need a Democratic Congress that will roll back the vast erosion of women's – especially young women's – reproductive health safeguards. We need healing – abortion has been a divisive wedge issue for too long – and we need prevention. The will is there: anti-choice and pro-choice legislators (but not Mark Kirk) have together put forth the Reducing the Need for Abortion and Supporting Parents Act (the Ryan-DeLauro Act).

Dan Seals is committed to progressive values – including safe, legal abortion – as part of the accessible, quality health care that all Americans deserve. Like so many of you, I have seen him speak sense – and listen to all viewpoints. He is committed to bringing us all together, hearing all voices and working constructively until we get back on track, for reproductive health rights and all that our country needs.

10th District Democrats Lead Efforts to Protect the Great Lakes

State Representative Karen May was concerned when she learned that the U.S. Coast Guard planned to conduct live fire machine gun practice on Lake Michigan just five miles offshore from Highland Park. She hosted a public meeting to discuss their plan and invited the Coast Guard, but they wouldn't attend. Upon learning of Rep. May's efforts and of the Coast Guard's plan, a group of local activists have now organized Citizens For Lake Safety (CLS), a multi-state coalition which they hope will halt the Coast Guard's efforts to turn the Great Lakes into the world's largest freshwater firing range.



David Borris, an active member of Tenth Dems, and one of the organizers of CLS, said that among the many reasons people have for opposing the plan, three concerns predominate. "The boaters don't want to lose their ability to enjoy the lakes. Almost everyone agrees it's not a good idea to put six thousand pounds of lead bullets into the lakes each year. And a lot of people don't think we need to militarize our border with Canada, with whom we have had peaceful relations since the end of the War of 1812."

The Coast Guard has not prepared an environmental impact statement for their proposal. The limited assessment that they did commission admits that the lead bullets will dissolve in lake water over time and will be consumed by animals in the lakes. The report acknowledges that lead is toxic to animals and humans, and says that people who eat fish from the lake are at greatest risk. Despite the risks identified in the report, the Coast Guard insists that there is no significant environmental risk.

Environmentalists aren't convinced. They point out that recreational fishers aren't allowed to put lead sinkers into lake waters, hunters aren't allowed to shoot lead shot, and industry is no longer allowed to dump lead into the lakes.

Although the Coast Guard claims they need to practice shooting on the lakes, other people believe that the Coast Guard could use simulators and other alternatives that would not interfere with anyone's use of the lakes and would not degrade

the quality of lake water. The Great Lakes contain 20 percent of the world's fresh surface water.

Under pressure, the Coast Guard agreed to hold a series of public hearings to discuss its proposal. The only one anywhere near Chicago will be on Wednesday, November 1 at 5:30 p.m. at the Genesee Theatre at 203 N. Genesee Street in downtown Waukegan. CLS hopes many people will attend and voice their opposition. The group also encourages people to sign an online petition at their website, www.CitizensForLakeSafety.org and to write their elected representatives.

Although the Coast Guard gave almost no notice of their plans, CLS was able to react swiftly. "We know how to organize this kind of effort," said Kevin Roos, who at age 25 is already working on his second congressional campaign in the 10th District. "We've had several years' experience opposing the war in Iraq and other Bush administration policies. We've developed our networks. We can do this."



Forget about bullets and bombs, the single greatest threat to the American dream is the acceleration of outsourced jobs sent overseas.


In the communications field alone, an estimated 400,000 jobs have been lost overseas since the year 2000. On average, America loses 12,000 to 15,000 jobs per month to overseas firms. ethics laws to be weakened? Of course not, but because his ambitions matter more to him than our opinions, Mark Kirk gave the Republican leaders what they wanted, and they thanked him by making him Assistant House Majority Whip.

Yes, Dan Seals has had help from the Republicans. But anyone who believes that he could have gone from being an unknown guy from Wilmette just a year ago, to being on the verge of pulling off an amazing political victory, is badly simplifying the facts.

From the start, people involved in Democratic politics in the 10th District saw something in Dan Seals that they liked. He faced an excellent Democratic opponent in the primary, but Dan easily won that race for one reason...he was able to attract grassroots volunteers who would work amazingly hard to help him win. They saw in Dan Seals an obviously intelligent and personable man, who actually seemed to care about people. "When you talk to him," someone told me during the primary campaign, "you really feel like he's listening."

He did listen. He went around the district meeting with Democratic political leaders, listening to what they had to say about what this district needed in a congressman. He also visited more houses than a top real estate agent, attending any small gathering that someone in the district would hold to introduce Dan to the neighbors. I saw him at a few of those gatherings, but I never got a chance to say much more than hello to him, because he was always busy listening to what person after person had to say about the issues facing the country.

And when it was his turn to talk, people liked what Dan Seals had to say, and they liked how he said it. Small donations came in, and began to add up to a decent sum of money for his campaign. The political experts began to notice that. They still scoffed at his chances of beating Kirk. One local political reporter basically told me not to waste his time by talking about Dan Seals, because without a big-name elected official running against him, Kirk was unbeatable.

Dan Seals probably heard that kind of talk much more than I did, but it didn't stop him from working toward his goal. Mark Kirk may still have a money edge over Dan Seals, but Kirk's candidacy does not generate anywhere near the kind of passion that exists among Seals
