## CONGRESS WATCH: DOUBLETALK DOLD'S SMOKE AND MIRRORS

With Election Day just over six weeks away, Doubletalk Dold is ratcheting up his efforts to appear busy in Washington. Trying to sound more like a Democrat than the partisan Republican he is, he has (co) sponsored some non-controversial legislation. After all, who can argue with resolutions condemning the violence in Orlando or appreciating U.S. Olympians? But on many of the really difficult problems – gun safety, funding to combat the Zika virus, protecting Americans from predatory financial advisors, and preserving and increasing Social Security and Medicare for seniors – Dold has been completely ineffective.

To make matters worse, Dold proudly touts his support for these issues knowing his support is purely rhetorical. While gun violence persists, the Zika virus infects Americans, and the Dodd-Frank regulations that would prevent another 2008 financial meltdown are under assault by ideologues in Congress, Dold continues to hide in the parliamentary procedural weeds while smiling to the cameras.

Dold tries to sound like a progressive by saying he would, potentially, vote for the legislation if it came to the floor. But it doesn't get there. It doesn't reach the floor because of Dold and his fellow Republicans.



Actions count, and in Washington Dold's actions have earned him a spot on Republican Speaker of the House Paul Ryan's list of "strong conservative candidates who share Chairman Ryan's vision of common-sense fiscal policies." No wonder Ryan held a private fundraiser for Dold while Congress was in recess.

Dold's counterproductive actions speak louder than the thousands of slick words spewing out of his media spin machine. When civil rights icon John Lewis led Democrats in the sit-in on the House floor to protest the lack of a real gun control bill, Dold was nowhere to be found. He explained his absence by claiming he was out drumming up support among Republicans he never would name. The fact is he FAILED to bring a single member of his caucus to support the Democrats and has FAILED to bring any gun bill to a vote in the House, siding with his party to ignore attempts to briefly put aside other activity in Congress so gun safety legislation could be debated and voted on.

And that wasn't the only time something like this happened. When

Social Security failed to give seniors an increase in the cost of living last year, and Republicans repeated their claims about how the program was failing, Dold voted "yea" on Paul Ryan's budget that would privatize Social Security and eliminate Medicare as we know it. On critical Zika funding, Dold, suddenly shy in front of a camera, has been silent while his right-wing colleagues add anti-abortion and other far-right amendments, delaying the passage of such critical legislation. And, when he thought no one was looking, Dold voted for the Investment Advisors Modernization Act of 2016, a bill that has been characterized by Americans for Financial Reform as removing the Dodd-Frank provisions that forced private fund advisors to work in the open.

That's not moderate. That's not independent.

Whether or not Donald Trump wins this November, we need to be represented in Congress by someone who does the right things, not someone who says what 10th District voters want to hear while doing what Paul Ryan wants him to do.

For those who really care about America and Americans, the only choice in the 10th District is Democrat Brad Schneider. Period.

This anger leads us nowhere. What do we have for ourselves after we have murdered our rival – jail, emptiness, a life squandered. When we have passed too early, we leave an inheritance of sadness, of hopelessness for those whom we have left behind. And, when we blame each other we lose opportunity; we lose that job or we don't move to a new city for a new life because we are afraid. Each individual loss mounts to a gigantic societal loss. There are cities throughout our country with so many jobs—and, of course, there are places with fewer jobs, where there still needs to be investment and encouragement for reestablishing the opportunity, the prosperity that once was there.

This takes courage. So many of the things that batter us are not under our control. We did not choose to be born into a family in poverty any more than we have chosen that our home be carried away by floods or that we have chosen to have cancer. It requires each of us to look long and hard at ourselves and ask, how can I make this better? How can I wrestle with my own challenges? How can I find my way back to the river of contentment, the river of fulfillment, the river of hope? And maybe, maybe the community, our collective governing promise, can help a little bit.

You know that Hillary doesn't like pretty words. That hasn't been her calling card. Her calling card is action. You know so much about her – you know that she has had successes and failures and that these have been writ large on the main stage. It's been humiliating at times, and it has challenged her to the deepest parts of her being. When she says she feels your pain – she does. speaking of lopsided financial strength, we learned that of all the contributions made to Illinois Republican legislative candidates, approximately 95 percent came from Rauner, whose intent appears not only to defeat Democrats but also to threaten Republicans who don't toe the Rauner line.

in a no-budget purgatory. But what really hit below the belt, Representative Lang said, was when Rauner cut hundreds of millions in child care assistance that affected 75 percent of single working parents who so desperately need this assistance. As a result of this heartless action, thousands of single moms and dads had to quit their jobs in order to be at home to take care of their children. So rather than try to keep families off welfare, Rauner's ridiculous and heartless child care cuts caused many of these working single parents to fall back into the welfare system.

after a long day of voting. At 3 a.m., her cell phone rang. It was her colleague Brad Schneider. There was a fire in the D.C. apartment building where she, Brad, and other members of Congress lived; and he was calling to make sure she could get out. He didn't know that Tammy had flown home that evening.

As Tammy recalled, "Brad asked, 'Do I need to come up and carry you down?' Of all those members in Congress, he was the only one who thought about me, thinking I was trapped in my apartment on the 5th floor. He was ready to walk back up and come and get me."

Karyn Davidman, Community Coordinator, Brad Schneider for Congress: "One of my favorite stories was when Brad organized a naturalization ceremony in Round Lake Beach. Almost 100 new citizens were taking their oath of citizenship that morning, and they all came with family and friends. The auditorium was filled. After the oath was administered, United States Citizenship and Immigration Services ran a beautiful video ending with the song "God Bless the USA." The last lines were, 'And I'd gladly stand up next to you, And defend Her still today, 'Cause there ain't no doubt I love this land, God Bless the U.S.A.' With this, one by one, the new citizens began to stand. They just all rose to their feet. Brad was on stage, tears flowing as he wiped them away. At the end of the song, the director said, 'And now, to say a few words, Congressman Brad Schneider...' Brad stood up and walked to the podium, looked at his prepared speech, folded it up because he could barely read through his tears and just spoke from his heart as he welcomed this roomful of new citizens. It was one of the highlights of his time in office."

Mary Carmody, President and Founder of the Midwest Veteran's Closet: "I was the Executive Director of Lake County Council for Seniors. I identified a need when a veteran had come to see us who desperately needed all sorts of help. We started Midwest Veteran's Closet. Someone called Congressman Schneider's office and told them that I was acting illegally because the Lake County Council for Seniors' nonprofit exemption was to assist seniors. Well, this gentleman was a senior. I thought I was acting appropriately. Brad's office told me I had to call the IRS. I told Brad, 'I'll clear this up, just give me your supersecret number, and I'll call them.' He said, 'I don't have a super-secret number. Why don't you just start your own 501(c)(3)?' I said, 'I didn't know how,' and he said, 'I'll help you.'

"If it weren't for Brad, Midwest Veteran's Closet wouldn't exist. We wouldn't be assisting 350 veterans a month with weather-appropriate clothing, housewares, furniture and food from our food pantry. Our newest program is delivering meals to disabled vets. If it weren't for Brad, we wouldn't be here. It's exactly the kind of help we should expect from a congressman."

Aaron Price and Carrie Price, Volunteers for Brad Schneider's Campaign: "We got to know Brad. We felt we could trust him. He would do what he said he was going to do. He treated us with dignity and respect. He showed generosity just by being nice and kind. Brad has also been to the Midwest Veteran's Closet, and he made poppies with us. We made 130,000 poppies for the American Legion. We do fundraisers with those." (Carrie Price is also a store manager in training at Midwest Veteran's Closet.)

**Yvette Ewing, Executive Director, The Fuller Center for Housing Hero Project Lake County:** "Brad connected our vision for a training center with Home Depot. The result was we received a grant and built a job training center and upscale thrift store. We are now building a kitchen to train veterans and under-resourced families in hospitality

service. I am a disabled veteran, helping other veterans. He was one of the first local politicians to really put his words into action. His team really followed through in helping the community."

Mary Eileen King, Constituent: "During the recession, I had a lot of issues with the economy, and I was really struggling. So when I was able to qualify for Social Security, that check was very important to me. But then there was a problem because I was working, and things got complicated. The bottom line is I went over what I was supposed to earn, so I was going to have to pay back some Social Security, which was fine. We set up a payment plan. The next year they withheld my entire Social Security check, so I had no income to pay rent or anything. I spent a lot of time trying to get this resolved. Finally, my sister said, 'Why don't you try your congressman?' Sure enough, I found Brad Schneider's office, and they were very helpful. They were so professional and well organized. I was getting emails from Brad who was in Washington at the time letting me know they were working on it. I definitely felt he was personally concerned. Definitely. Within a couple weeks, the situation was resolved. Without Brad and his office, I wasn't going to pay rent or utilities. It was a question of getting things done and getting somebody to listen. Brad and his office listened, and they acted. To me, so many politicians are in it for the power and fame and the ego building. Brad is definitely not like that. He is there so much for his constituents, and he is so accessible and has such a great support system and family."

The Grayslake businesswoman – potentially the first Democrat to be reelected in this district in history – has amassed an amazing record in Springfield, championing women, families, and veterans; fighting the scourge of opioid addiction; protecting the environment; and changing how government works.

Here are just a few examples:

- House Bill 5576 extends insurance coverage to almost all approved contraceptive drugs, devices, and products. Companies also would be required to provide 12 months of contraceptives at one time.
- Senate Bill 3401 allows veterans' assistance commissions to provide mentoring and mental health and substance abuse programs in conjunction with Veteran & Service Members Courts that were specifically created to help veterans facing addiction.
- Senate Bill 1466 allows pharmacies to carry life-saving heroin overdose medication and expands access to families. Another piece of legislation would expand "Good Samaritan" protections to first responders who apply life-saving overdose medication.
- Senate Bill 1202 would allow for no new permits for fracking on or under state-owned land.
- Senate Bill 659 will create a website to help individuals create new businesses or relocate to Illinois.
- SB 1430 allows counties to consolidate township assessors by referendum or resolution.



"That's what happens if you focus on public service and work for the good of your district," said Bush. "Most of the political squabbling is just noise – the real work is done by legislators who put their heads down and fight for their communities."

With the support of lawmakers in Zion, Bush has cosponsored legislation requiring the collection of an impact fee from companies that store their nuclear waste in the community. That bill would affect Exelon, which closed its nuclear power station there in 1998.

Bush has also become a role model for other lawmakers, cutting her own pay and perks and turning down a state pension.

Because of her efforts, the Illinois chapter of the Sierra Club and Personal PAC, which focuses on electing pro-choice candidates, have endorsed Bush for reelection. A full list of her endorsements is included on this page.

#### **Environmental Town Hall**

State Representative Robyn Gabel (D-18), State Senator Daniel Biss (D-9), and I held a captivating environmental town hall meeting on Monday evening, September 12, at the Evanston Ecology Center. We had a packed room, engaged crowd, and fascinating conversation. Our speakers included representatives from the Illinois Environmental Council, the Sierra Club, the Center for Neighborhood Technology, and the Natural Resources Defense Council.

The message was clear: we need to work to undo the damage that has already been done to our environment, we have to act now to make more clean energy sources available, and we have to save our pollinator population.

The conversation began with a discussion of lead in our water, especially in our schools. The Sierra Club discussed the importance of testing all water sources in the schools. If there is lead found, those water fountains, etc., need to be turned off. There was also discussion about filters residents can put on their faucets at home to ensure there is no lead in their drinking water. Consuming lead can be very harmful to children whose bodies are still growing and cannot process it effectively.

The Clean Jobs Bill continues to make progress. Illinois needs to build more clean energy sources. We have to make sure our future includes renewable energy such as wind and solar. This will not only improve our environment, it will also create thousands of jobs. The negotiations surrounding this legislation continue between our environmental organizations and the energy industry.

An intriguing part of the discussion focused on pollinators. These are insects, like bees and monarch butterflies that are being negatively impacted by pesticides and insecticides used in our communities and on our farms. Weed killers such as Round Up have been so effective in killing milkweed, the only food source for monarch butterflies and where they lay their eggs, that this source is no longer available to them

in many areas. This is also destroying the bees and their hives. We depend on bees to pollinate plants that are part of our food source. We need to advocate for the removal of neonicotinoid from these pesticides that are causing these problems. Home Depot, Lowe's, and Walmart have committed to stop selling products that contain neonicotinoids over the next several years. We need to continue pressuring the makers of these products to stop selling them in the marketplace and to replace them with less harmful products.

One way you can help is to purchase monarch butterfly license plates from the Secretary of State's office. The proceeds will go to planting milkweed along the roadsides to help repopulate the beautiful monarch butterfly population!




