

Remember when you were a little kid and you locked the door to your room and didn't come out for a long time? Your moment and at some point knocked on the door and said. "What are you doing in there?" Your

governments. He will bring these new ideas to the Cook County Board as 14th District commissioner.

Full House Hears Congresswoman Cheri Bustos' TDU Talk on Hope from the Heartland

Tenth Dems University was honored to welcome Democratic Congresswoman Cheri Bustos (IL-17) on Monday, April 3rd, to a crowded auditorium at the Highland Park Library. Her lecture, entitled "Hope from the Heartland: How Democrats Can Better Serve the Midwest by Bringing Rural, Working Class Wisdom to Washington," was a clear and concise discussion of how Democrats have lost too many voters and how to get them back. Bustos began by talking about her own background growing up on a farm near Moline, in an area where there were more pigs than people, and about how her father's political activities introduced her to such Democratic luminaries as Paul Simon and Richard Durbin. Her

interest was investigative journalism, and she worked for *The Quad Cities Times*. She ran for Congress in 2012. And in 2016, at a time when Trump won 14 of 17 counties in her district, she won re-election by 20 points, one of only 22 Democrats in Trump districts to do so.

What, she asked, can Democrats take away from this? First, she explained that areas like her district have been hit hard economically. Many plants have closed and moved their jobs elsewhere, leaving folks to scramble for a living. Concerned about, as she calls them, kitchen table issues, such as health care, paying rent, and college affordability, many of her constituents bought into Donald Trump's outsider image more in desperation than true belief. She strongly feels that the road back to a majority in Congress is paved through purple districts such as hers, especially in the Midwest.

The key thing Bustos does is to connect with her constituents by showing up, listening, and focusing on what they say are their problems. Bustos emphasized the need to discuss the issues that bind us together and not those that divide us. She spends significant time doing "shadow shifts," which means going to someone's job and learning what they do to create a connection with her constituents. What is important to understand is what they are feeling. She finds that many of their conversations revolve around the need for infrastructure repairs, good-paying jobs, and affordable education rather than hot-button topics. To this end, Bustos has been involved in setting up a "boot camp" for prospective candidates who can flip their districts from red to blue. She concluded by saying that we've got the right people, now it is up to us to get people registered and out to vote.

A spirited question and answer session followed her talk. Our thanks to Congresswoman Bustos for a fantastic evening.

Bob Morgan: Healthcare Activist and Community Leader

Bob Morgan, a Democratic healthcare activist from Deerfield, is running for State Representative for the 58th District, which includes Lake Bluff, Lake Forest, Highwood, Highland Park, Deerfield, Bannockburn, and portions of Glencoe and Northbrook.

Bob has long been active with Tenth Dems in many areas, including as an attorney with our Election Protection Team, making sure that everybody who is entitled to vote is allowed to vote, although this campaign is his first run for public office. He lives in Deerfield with his wife and two small children. Bob's career has focused on healthcare and health policy, and he has worked as both an attorney and an advocate, beginning his career by



traveling throughout the United States to help struggling communities establish better healthcare for their residents.

Bob Morgan began his political involvement with the Obama campaign in 2008, and served as the campaign's Jewish Outreach Coordinator in Florida. His primary focus, though, has been on healthcare advocacy. He has worked as a healthcare attorney for the State of Illinois and also as legal counsel to implement Obamacare's Medicaid expansion and other Affordable Care Act components. He also helped to develop the law permitting Illinois residents with specified medical conditions to use medical cannabis. In 2015, Bob transitioned to the private sector.

Bob was motivated to run for office shortly after Donald Trump's inauguration. He sprang into action to fight injustice by helping to seek the

release of detainees stranded after Trump's first travel ban. In addition, Bob felt that both the state and federal governments were failing to act on many important issues, such as gun violence prevention, reproductive rights, and improving educational opportunities.

Bob is also very concerned about Bruce Rauner's disregard for social services and the needs of so many in the state. Illinois is failing to protect its children; and Bob wants to see improvements in social services, education, access to healthcare, and improved healthcare outcomes. As the father of two young children, Bob decided that the "idea of letting Illinois become a failed state is something I won't accept." He knew he couldn't sit on the sidelines and just complain, but had to take an active role in becoming part of the solution to the state's problems.

Bob is also worried about the state's pension system. Both of his parents are retired schoolteachers, and he is disheartened by Springfield's failure to solve the unfunded pension issue. As he explained, "doing nothing about unfunded liability is not an option." In fact, the state's pension liability might crowd out funding for education and healthcare unless the issue is addressed.

As the Democratic candidate, Bob wants residents of the 58th District, as he explained, to regain "faith and confidence that government can be an agent for good." Bob is dismayed that the embattled Republican governor would recruit other Republican governors from nearby states to appear in commercials that denigrate our state. That is simply unacceptable.

Bob Morgan is excited by the energy he has already experienced on the campaign trail and is ready to take on the challenge of fighting for system change.
