YES, WE DID! The Obama Record on Jobs and Workers

A small child has fallen to the bottom of a hole. You climb into the hole and begin scaling the walls with child in tow. You assumed everyone wanted to save the child, but you were wrong. Some people prefer that you fail, even if it kills the child. Those people are doing everything they can to keep you from getting out of the hole. Even so, you progress up the wall.

When Barack Obama took office, the economy was falling into a hole along with everyone's jobs. While he acted immediately to reverse that decline, Republicans declared that their number one priority was to make President Obama a one-termer. Even if it kills the country. So they blocked nearly every proposal that was in danger of returning Americans



Nonetheless, through a series of initiatives, President Obama has made progress. The child is starting to see light within reach at the top of the hole.

But it isn't enough just to create jobs, if the jobs are dangerous or stripped of dignity. Luckily, President Obama and the Democrats have made progress in that area as well, giving teeth to OSHA enforcement, supporting unions, and creating a fairer workplace.

To create jobs, the President's first steps upon taking office included the stimulus (already in the works by congressional Democrats) and the auto industry bailout. Both initiatives were vociferously opposed by Republicans. Both have worked. The stimulus, known as the American Recovery and Reinvestment Act, provided funds to hire teachers, police, and firefighters; additionally, it financed highway and transit improvements and promoted small business. According to Factcheck. org, "The truth is that the stimulus increased employment by between 1.4 million and 3.3 million people. compared with what employment would have been otherwise." The Congressional Budget Office reported that the stimulus lowered unemployment between .7 and 1.8 percent. The stimulus further aided the unemployed and had a "Buy American" provision that any public works project must use materials manufactured in the United States.

The auto bailout also created jobs, about 113,000 in a two-year period per www.politifact.com.

More recently, President Obama proposed the American Jobs Act, a comprehensive bill that combined tax incentives with programs for

unemployed workers and a "Project Rebuild" to put people to work rehabilitating homes, businesses, and communities. Republicans blocked that bill but then proposed an amendment, which had nothing to do with job creation and everything to do with undoing healthcare, Wall Street reform, and attempts to regulate greenhouse gas emissions. Invoking "We Can't Wait," Obama used his executive powers to skirt Republican roadblocks. His October, 2011 executive order created BusinessUSA, a one-stop online platform on federal programs for businesses that want to export goods. A second order sped moving federal research from the laboratory to the marketplace.

In November 2011, Republicans finally supported two Obama job proposals, one to help jobless veterans and another to repeal a three percent withholding requirement on government contractors that would have held up the cash flow needed to hire new workers.

President Obama's policies have, in fact, created more jobs in one year than Bush did in eight. (http://thinkprogress.org/ politics/2011/01/07/137866/obamamore-jobs-bush/?mobile=nc) While Bush had a net gain of just over one million jobs in eight years, Obama created growth of 1.1 million jobs in 2010 alone. The Department of Labor reported that unemployment fell from 9.4 percent to 8.5 percent in 2011. and January, 2012 showed a further drop to 8.3 percent, a three-year low. Under President Obama, the economy has seen 23 consecutive months of job growth.

But creating jobs only matters if those jobs are decent, which is why unions are so important. Without

collective bargaining power, the individual worker is trampled by the economic might of the employer. Unions level the playing field, and the Obama administration has said so. In March, 2011, when Scott Walker was ramming his anti-union budget through the Wisconsin legislature, Vice President Joe Biden told a meeting hosted by the AFL-CIO that "the only people who have the capacity—organizational capacity and muscle—to keep, as they say, the barbarians from the gate, is organized labor. And make no mistake about it, the guys on the other team get it. They know if they cripple labor, the gate is open, man. The gate is wide open. And we know that too." (http://www.huffingtonpost. com/2011/03/17/biden-unionbarbarians-labor n 837346.html) The Milwaukee Labor Press opined that Obama's silence on Gov. Walker's union bashing was a media myth. In February 2011, Obama protested the vilification of public employees at a bipartisan meeting of the nation's governors.

But this administration has done much more than talk. The National Labor Relations Board finalized rules last December that would limit an employer's ability to obstruct a union election. Employers would be forced to postpone any legal challenges until after the vote. Contrast this with House Republicans, who passed a bill last July that gave employers a loophole to fire workers who tried to unionize. The U.S. Chamber of Commerce complained that the new NLRB rules have "no conceivable purpose but to make it easier for unions to win elections." (http://thehill.

com/business-a-lobbying/200759labor-board-finalizes-union-electionrule)

The Chamber filed federal suit to block the rules. The NLRB enacted the rule before expired appointments could have prevented passage. Senate Republicans remained in session to cheat Obama from making recess appointments. But rather than cripple the NLRB, Obama made them anyway. Senate Republicans are naturally filing suit.

The administration has further proposed rule changes that would include domestic workers in the coverage of minimum-wage and overtime pay laws. Another rule protects pilots from working overly long hours past the point of fatique.

And who can forget Lilly Ledbetter, the Act to insure equal pay?

As for on-the-job safety, President Obama has reversed Bush's overreliance on voluntary cooperation. In 2009, OSHA issued 68,000 citations, an increase of 167 percent over Bush's last year, and issued 114,000 in the first half of 2010. In 2008, OSHA cited 203 willful violations, which increased to 1,166 in Obama's first year. Safetynewsalert.com credited the crackdown not just from increased funding but "support from the top." (http://www.safetynewsalert.com/report-shows-how-obamas-osha-has-stepped-up-enforcement/)
